A complainant must specifically identify one or more respondents, a violation of Colorado campaign finance rules and regulations (Constitution Article XXVIII, the Fair Campaign Practices Act, or the Secretary of State's rules concerning Campaign and Political Finance), and allege specific facts to support a legal and factual basis for the complaint. Today, Gov. Jared Polis released a letter he is sending to every taxpayer in Colorado, along with their \$750 TABOR refund check. This letter blatantly misleads voters by refusing to say the word "TABOR" or "Taxpayer Bill of Rights." Instead, the Governor uses his own campaign language of "Colorado Cashback," a phrase he coined during his campaign for re-election.

Due to the Governor's use of campaign language, this letter is a campaign mailing and not an official "instructional letter" as he told the media. The Governor's refusal to call the refund a TABOR refund, after he campaigned against TABOR refunds in 2019, demonstrates that he is promoting his own campaign instead of being honest with voters and informing them of the true source of the refund: TABOR, not his campaign term "Colorado Cashback."

Furthermore, Jared Polis is spending \$2.7 million in state funds to send this letter prior to his election. \$1.7 million is the specific cost to print and mail. (Spreadsheet of cost attached.) The Governor is using taxpayer dollars to send his own campaign mailer, and this is a plain campaign finance violation. This letter is not in the ordinary course of business, as no Colorado Governor has done this before -- including Jared Polis.

The specific laws the Governor is violating include:

Article XXVIII, Section 3 of the Colorado Constitution - prohibiting campaign donations from the state or other government entities. The state is spending \$2.7 million on this campaign mailer for Jared Polis.

Article XXVIII of the Colorado Constitution, C.R.S. 1-45-103(9), C.R.S. 1-45-103 (15.5) - all define electioneering as a communication this close to an election that unambiguously refers to the candidate. Jared Polis is directly named three times in this letter.

C.R.S. 1-45-108.3 - a campaign mailer must have a disclosure; there is none.

C.R.S. 1-45-117 - No more than \$50 in public money may be spent; \$2.7 million is being spent in taxpayer funds to promote Jared Polis' campaign.

The Governor also failed to report the \$2.7 million in state funds as a campaign contribution.
